Our history and expertise in bringing families together has forged the way for our national open Embryo Donation program, the only one of its kind in Canada

- Human Resources/Professional Development Experience in planning and implementing human resource strategies, executive compensation, performance management systems, succession planning and development
- Social Work Experienced in social work and its practices with the aim of helping people who have social disadvantages or personal problems
